Siegfried Lewark

Twenty years of studying changes in forestry work and education

My way to being professor of Forest Work Science was similar to that of many colleagues who were professors of applied disciplines at German faculties of forest sciences at the same time. It started with a motivation to study in a field of natural sciences. Then I was selected for a career in a state forest service, in my case in Lower Saxony. I did an internship in a forest service of that time – the 1960s, then after graduating from university and the two year preparation service in that forest service, I ended up at the Faculty of Forest Sciences of the University of Freiburg.

Work in rural areas has developed dramatically during the past twenty years. Through mechanization and rationalization tools and machines, tasks, working conditions and terms of employment have changed fundamentally. In forestry this became particularly obvious, which consequently had an impact on the research programme of my work science research group.

My field of research has broadened over time, which may be seen from the contents of recent publications and PhD dissertations:

- competence development, organizational learning
- forest contractors' work
- gender studies, women's work
- · working conditions and innovations in wood industry
- occupations of graduates of forest science study programmes
- e-learning

The twenty years I spent as a Professor for Forest Work Science were full of motivation and challenges, marked by the far reaching changes of working life and a permanent learning process of my own. Making contributions to the shape of these dynamic changes in practice and education have been of special importance to me.
